To the person in ②:

At the hearing, the judge can renew the current restraining order for up to another 5 years or permanently. Before the hearing, you can file a response on form DV-720. You *must* continue to obey the current restraining orders until the hearing. At the hearing, you can tell the judge why you agree or disagree with he request to renew the orders against you. If the restraining orders are renewed, you *must* obey the orders even if you do not attend the hearing.

4 Service and Response**A To: Person Asking for Renewal of Order**

Someone 18 or over – **not you or anyone else protected by the restraining order** – must personally “serve” a copy of the following forms on the person in ② at least _____ days before the hearing.

- DV-700, *Request to Renew Restraining Order*;
- DV-710, *Notice of Hearing to Renew Restraining Order* (this form);
- DV-720, *Response to Request to Renew Restraining Order* (blank copy);
- DV-130, the current *Restraining Order After Hearing* for which renewal is requested.

After the person in ② has been served, file Form DV-200, *Proof of Personal Service*, with the court clerk. For help with service, read Form DV-200-INFO, *What is Personal Service?* **Bring a copy of the Proof of Service to the court hearing.**

B To: Person Served with Request to Renew Order

If you want to respond in writing to the request to renew the restraining order, fill out form DV-720, *Response to Request to Renew Restraining Order*. File the original with the court, and have someone 18 or over – **not you** – mail a copy of it to the person in ① at least _____ days before the hearing. Also file form DV-250, *Proof of Service of Response by Mail*, with the court before the hearing. **Bring a copy of the Proof of Service to the court hearing.**
